

PermaSEAL 8 Mesh

Description:

PermaSEAL 8 Mesh is a high quality meshed membrane and is part of the Perma-Seal Range. It is one of the toughest and thickest on the market today and is made from 0.65mm high density polyethylene, able to withstand everyday site impact damage.

PermaSEAL 8 Mesh should be chosen as a wall membrane if a dot and dab plasterboard finished is required and also provides an excellent substrate for lime mortars, renders and plasters. The square design of the 8mm studs is perfect for corner detailing and managing any protrusions or nibs on the wall surface.

Our innovative PermaSEAL Quick Plug is used when fitting the PermaSEAL 8 Mesh to the wall and if a below ground waterproofing system is being installed then it should be used with our Drainage Channel or Floor drain perimeter drainage systems.

PermaSEAL 8 has a 30 year guarantee against deterioration with a life expectancy of at least 50 years (DIN 9001:2000)
